

## MEMBERSHIP FEES

The following Orienteering Victoria membership fees for 2012 include subscription to the Australian Orienter. These fees were set at the October 2011 Council meeting and are inclusive of GST.

Registered official	\$18.00 (only includes public liability insurance cover when organizing, controlling or course setting an event. Does not include any other Orienteering Victoria membership benefits). Registered officials upgrading to full membership are given credit for any registered officials membership fee they have paid with respect to that year

### Club Affiliation Fees:

Large Clubs	\$840.00
Small Clubs	\$420.00
Remote Clubs (AWOC)	\$230.00

Small clubs are defined as those with less than 25 members and less than \$5,000 annual turnover.

### Conditions of Membership

\*Age is taken at the 31st December.

\*A junior is an individual aged 20 or less.

\*Student application to be supported by a copy of the current student card.

#Family applications consist of any members of a single family living at the same address.

Fees are payable for the calendar year, and are due by the end of February.

FIRST TIME MEMBERS only who join between 1<sup>st</sup> July and 30th September will pay half of the present year's fees. After 30th September, full payment of the present year's fees will give membership until 31st December of the following year.

## EVENT ENTRY FEES

Orienteering Victoria does not set "standard" entry fees. It is the prerogative of each club running an event to set the base fees for that event. Clubs may also agree amongst themselves as to a standard entry fee for all events in any one event series. There is no maximum fee set by Orienteering Victoria. Refer to separate document "Guidelines for Entry Fees".

For event entries, a family is defined as one or two adults and/or any children under 21 looking to at least one of the adults as a parent.

**EVENT LEVIES**

Event Levies for 2012 for a Senior OV full member, including GST, are as follows (as set at October 2011 Council Meeting). Orienteering Australia (OA) levies are included as detailed below:

Individual Long Distance Championships – foot and MTBO <i>includes OA levy component \$3.60</i>	\$11.00
Badge events and National League events - foot and MTBO <i>includes OA levy component \$2.40</i>	\$8.50
Middle Distance Championships, Sprint Distance Championships, State Series, Victorian Relays or equivalent – foot and MTBO <i>includes OA levy component \$0.40</i>	\$6.40
Club/other bush events/local series – foot and MTBO <i>includes OA levy component \$0.40</i>	\$2.30
Park/street events <i>includes OA levy component \$0.40</i>	\$2.60

**For all event levies:**

- rates quoted above are senior members. Add \$6 (State Series or above) for senior casual members. In all cases junior rates are 50% of the senior rate and family rates 250% for the OV levy component – the OA levy component is a flat rate per person
- Rates include a Sportident levy for all events of State Series level or above. If events below State Series level use OV-owned Sportident equipment, an additional levy of \$1/senior applies. For team-based events using Sportident, one levy per SI stick is payable
- Orienteering Australia levies on events are included. In the event of unforeseen increases in OA levies during the above period, OV reserves the right to pass on said increases
- Rates listed apply until the end of 2012 (except for park/street levies, which apply to the end of the 2012 - 2013 Summer Series)
- The Victorian Relays, the Victorian Middle Distance Championships and the Victorian Sprint Distance Championships are at the State Series rate
- Club/other bush events - includes Season Opener, Blodslitet, Maxi 3 hour, Winter Classic (if not SS events), Eureka Challenge (if not SS event), Kooyoora Challenge (if not SS event), Night O Champs, ARDF Championships, Christmas 5-Days and any other non-classified event unless the Council decides otherwise
- Melbourne Summer Series MTB events are levied at the current park/street rate
- Club training activities are not levied, as long as there is no entry fee charged. The club will be responsible for promotion, funding and other support.
- Events designated as fundraisers (eg for Junior Squad) will have levies waived, on the proviso that these events are fixtured in advance as such and receive OV Board approval; and that all proceeds after deduction of expenses are directed towards the fundraising. OA levies will still be payable.

A multiple series ticket discount of 12.5% per season ticket applies (set in accordance with the pricing structure agreed by the Park and Street Subcommittee and subject to review prior to commencement of each season. Accordingly, season ticket levies are discounted by the same percentage.

**Additional notes:**

Payment of levies should be made, accompanied by the appropriate form enclosed, to the Orienteering Victoria Treasurer immediately after the event for which they are due. For park and street events, levies should be paid every three months by the Park and Street Treasurer on behalf of clubs.

In all cases, junior rates are calculated using a factor of 50% of the senior rate and family rates calculated using a factor of 250% of the senior rate, for the OV levy (OA levies are not discounted).

Member prices do not apply to registered officials or casual members, only full members.

Ski-O events presently do not attract an Orienteering Victoria levy but the OA levy of 0.40c is payable.

First time competitors at a Bush event will only be levied at the full members rate. Competitors on easy/very easy courses at State Series events are charged entry at the junior rate, and levies will be charged accordingly.

All members of a group pay as individuals, unless they share a map and control card.

Event levies not paid 3 months after the event will attract interest at a rate equivalent to that earned by Orienteering Victoria on its deposits.

For the purpose of event levies, two day events count as two events, unless the Board decides otherwise. This rule does not apply to Easter 3-Day, which is levied as one event.

If an entry fee is received by a club, a levy is payable on that competitor – including in a pre-entry event for a competitor who does not start. No levy is payable if, and only if, an entry fee is not received.

Any club found to have understated its event attendance in payment of levies by more than 10% is liable to pay five times the difference between what they paid and what they should have paid, unless they can satisfy the Council that the discrepancy is due to a genuine error or misunderstanding.

Expenses for Controllers should be claimed from the organizing club.

**SportIdent Card ('SI Stick') Hire**

The hire price will be \$3.00 per card per event, subject to a maximum capped rate of \$7.50 for families requiring 3 or more cards at one event. Persons failing to return hired cards will be charged the current replacement cost of the card.

### **OA (Orienteering Australia) FEES AND LEVIES**

OA charges a number of fees and levies to State Associations to cover the operating costs of the national body, the funding of national teams, and to pay for Victoria's share of public liability insurance and promotional brochures. An Annual State Registration Fee is charged based on state membership numbers for the last 5 years, and levies are charged on event entries. OA levies are not discounted for juniors, families or life members. Refer to the OA website for more details.
